The Directorate of Education, Andaman and Nicobar Administration is in process of filling the vacant posts of Laboratory Assistant under Departmental Promotion quota from amongst the eligible employees of the Department of Education. As provision in the Recruitment Rule for the post of Laboratory Assistant Notified vide Andaman and Nicobar Gazette No- 375 dated 02-12-2010, for recruitment by promotion to the post of Laboratory Assistant, the eligible candidates must qualify in the written test to be conducted by the Department/Administration.

Apropos to provisions of the Recruitment Rule, the Directorate of Education will conduct a written test for all the eligible employees of the Department of Education on Sunday the 13th Day of April, 2025. Written test shall be held at Govt. Boys sr. Sec. School, Middle Point, Sri Vijaya Puram from 1000 hours to 1200 hours. Hall ticket shall be issued to all the eligible Departmental candidates from the Recruitment cell of the Directorate of Education on 11-04-2025.

- He written test will be of single paper covering the syllabus of subjects- Physics, Chemistry and Biology mentioned above.
- The question paper shall comprise of 100 questions carrying 01 (one) mark each. Qualifying marks in the written test shall be 33.
- All questions will be of objective type and answers are to be recorded on OMR sheet.
- The duration for the exam shall be 02 (Two) hours.

It is mandatory for all the eligible candidates to appear and qualify in the written test. In case of failure to qualify in the written test, the candidature for the forthcoming DPC for consideration of promotion to the post of Laboratory Assistant shall not be considered. Request for change in test schedule and re-test shall not be considered.
