NOTICE

The Department of Education invited applications for consideration of compassionate appointment vide No. 2-14/Estt/2019-Edn/765 dated 06-02-2023. The eligible / ineligible applicants concerned may submit their claims and objections, against the scored points / remarks with supporting documents / evidence to the Directorate of Education within 15 days from the date of publication. Claims & objections received after the stipulated period will not be entertained.

It may be noted that the points awarded are provisional and subject to verification upon submission of required documents by the applicants. In case of non-submission of required documents, the corresponding points shall be treated as Nil and the total points will be revised accordingly. Further, non-submission of other essential documents such as un-married certificate and NOC from other dependent members may lead to rejection of candidature for considering Compassion Appointment.
